



CoinDesk Indices Announces Update to Daily Observation Time for CESR™

December 18, 2023 – Effective, December 23, 2023, the Observation Time used to calculate CESR will be updated from 13:00 to 13:05 Eastern Time following a review of the methodology by CoinFund’s Rates Governance Committee. An updated methodology document will be published on CoinFund’s [website](#) prior to the effective date.

The update to the Observation Time is due to latency detected on the Beacon Chain that causes single epoch inconsistencies during the Observation Period used to calculate CESR. Shifting the Observation Time to 13:05 better ensures the daily CESR calculation uses the standard 225 epochs.
