



CoinDesk Indices Announces Final October 2024 Reconstitution Results for its CoinDesk Market Select Index

September 18, 2024 – CoinDesk Indices (“CDI”) announces final October 2024 reconstitution results for its CoinDesk Market Select Index (“CMIS”) based on data from September 16, 2024. Final reconstitution results will be implemented at 4p.m. Eastern Time on October 2, 2024.
