## **Reconstitution Implementation**

Index supplies and adjustment factors will be determined on April 23, 2025, and used to calculate the initial weights including applying the 5% constituent capping. Final weights will be calculated on April 30, 2025, at 4 p.m ET using the Settlement Reference Rates on April 30, 2025 at 4 p.m. ET and the index supplies and adjustment factors determined on April 23, 2025.

The index supplies and final constituent weights determined above will be used for the CoinDesk 80 Index (CD80) and the CoinDesk 80 Settlement Index (CD20SETT).
