

CoinDesk Indices Announces October 2024 CoinDesk Market Index Reconstitution Results

September 18, 2024: CoinDesk Indices has completed the October 2024 reconstitution of the CoinDesk Market Index (CMI) and reference rates based on data available as of September 16, 2024. The reconstitution will be effective at 4PM Eastern Time on October 2, 2024, and includes updates to circulating supply data as well as constituent changes.

As part of the reconstitution changes, the CoinDesk Market Index will implement the following updates effective October 2, 2024:

- Polygon's (MATIC) token was migrated to its new Polygon Ecosystem Token (POL)
 earlier in September. The CoinDesk Market Index will implement this change and
 begin using POL.
- CoinDesk Indices is updating the ticker for Render token from RNDR to RENDER.
 The CoinDesk Render Reference Rate will continue to be sourced from Render (Solana) exchange pairs.

The reconstitution resulted in the following additions and deletions to the CMI family.
