

CoinDesk Indices Announces Updated March 2025 Reconstitution Results for the CoinDesk Memecoin Index

February 24, 2025 (Update) – Following the <u>announcement</u> by Probit Global to suspend trading of SHIBTC, CoinDesk will not add SHIBTC to the CoinDesk Memecoin Index at the end of February and there will be no replacement. The updated additions and deletions are listed below.

CoinDesk Indices ("CDI") announces March 2025 reconstitution results for the CoinDesk Memecoin Index based on data from February 12, 2025. These changes will be implemented at 4 p.m. Eastern Time on February 28, 2025.

Weighting Adjustment Factors (WAFs) will be determined on February 21, 2025, and used to calculate the target weights.

Final weights will be calculated on February 28, 2025, at 4 p.m ET using the Reference Rates at that time and the WAFs determined on February 21, 2025.
