



CoinDesk Indices Announces Changes to its Single Digital Asset Price Indices

April 12, 2024 – CoinDesk Indices has completed its quarterly review of the CoinDesk Single Digital Asset Price Indices, including XBX, for potential changes to the contributing exchanges used to calculate the indices.

Based on this review, the following modifications will be implemented over the 24-hour period ending at 4p.m Eastern Time on Sunday, April 28, 2024.
