

CoinDesk Indices Announces Updates to its List of Eligible Exchanges

April 4, 2023 – CoinDesk Indices will delete Bittrex from its list of eligible exchanges used to prices its Single Digital Asset Price Indices and Reference Rates and review several other exchanges for possible addition. Digital asset exchanges must meet the criteria outlined in the CoinDesk Digital Asset Indices Policy Methodology. Eligibility is reviewed on a regular basis.

Exchange Deletion

CoinDesk Indices will remove Bittrex as an eligible exchange based on its <u>announcement</u> that it will close its U.S. operations effective April 30, 2023. In addition, Bittrex's historical data will no longer be included in the analysis used to determine index reconstitution changes going forward.

Index Impact

Bittrex pricing is currently used in the pricing of CoinDesk Reference Rates included in Table 1 below. These reference rates are used as constituents in certain CoinDesk multi digital asset indices as detailed in Table 2. Impacted indices will be reviewed and a separate notification will be sent out detailing any changes that may be implemented.
