

## CoinDesk Indices Announces July 2025 Reconstitution Results for the CoinDesk 80 Index

**July 3, 2025** – CoinDesk Indices ("CDI") announces July 2025 reconstitution results for the CoinDesk 80 Index based on data from July 1, 2025. These changes will be implemented at 4 p.m. Eastern Time on July 31, 2025.

## **Reconstitution Implementation**

Index supplies and adjustment factors will be determined on July 24, 2025, and used to calculate the initial weights including applying the 5% constituent capping. Final weights will be calculated on July 31, 2025, at 4 p.m ET using the Settlement Reference Rates on July 31, 2025 at 4 p.m. ET and the index supplies and adjustment factors determined on July 24, 2025.

The index supplies and final constituent weights determined above will be used for the CoinDesk 80 Index (CD80) and the CoinDesk 80 Settlement Index (CD20SETT).
