



## CoinDesk Indices Update Regarding April 2023 Single Digital Asset Price Indices Exchange Review

**April 4, 2023** – CoinDesk Indices will perform the quarterly review of contributing exchanges for its Single Digital Asset Price Indices during the month of April. There are several important updates regarding the review process as detailed below. The review schedule can be found in Table 2 below.

### Important Updates:

*Exchange Removal:* Bittrex recently announced that it will close its U.S. operations effective April 30, 2023. Bittrex is not a current contributing exchange in any of CoinDesk’s Single Digital Asset Price Indices so there is no impact to the calculation of these indices. For the purposes of the quarterly review, CoinDesk will not incorporate Bittrex’s historical exchange volume in the analysis.

*Watchlist Update:* CoinDesk reviewed the list of non-contributing exchanges and based on its previously announced change to reduce the watchlist volume requirement from 5% to 4%, the following exchange will be eligible on the April 2023 Watchlist:
